Notes for completion of the proxy form

- 1. Pursuant to Article 40(1) of the Companies (Uncertificated Securities) (Jersey) Order 1999, to be entitled to attend and vote (or appoint a proxy to attend and vote) at the General Meeting (and for the purpose of the determination by the Company of the votes they may cast), shareholders must be registered in the register of members of the Company at close of business on 25 January 2022 (or, in the event of any adjournment, close of business on the date which is two working days before the time of the adjourned meeting). Changes to the register of members after the relevant deadline shall be disregarded in determining the rights of any person to attend and vote at the General Meeting. You can only appoint a proxy using the procedures set out in these notes and the notes to the notice of the General Meeting.
- 2. In light of the COVID-19 pandemic, shareholders are encouraged to appoint the chair of the meeting as their proxy to exercise all or any of their rights to attend, speak and vote at the meeting. This can be done by leaving the relevant box blank.
- 3. To appoint as your proxy a person other than the chair of the meeting, insert their full name in the relevant box. If the box is left blank, the chair of the meeting is deemed to be your proxy.
- 4. In the case of a shareholder which is a company, this Form of Proxy must be executed under its common seal or signed on its behalf by an officer of the company or an attorney for the company.
- 5. Any power of attorney or any other authority under which this Form of Proxy is signed (or a duly certified copy of such power or authority) must be included with this Form of Proxy.
- 6. In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's register of members in respect of the joint holding (the first-named being the most senior).
- 7. If you submit more than one valid proxy appointment in respect of the same share, the appointment received last before the latest time for the receipt of proxies will take precedence. If the Company is unable to determine which was last received, none of the proxy appointments shall be treated as valid in respect of that share.
- 8. A vote withheld is not a vote in law, which means that the vote will not be counted in the calculation of votes for or against the resolution. If no voting indication is given, your proxy will vote or abstain from voting at his or her discretion. Your proxy will vote (or abstain from voting) as he or she thinks fit in relation to any other matter which is put before the General Meeting.
- 9. The right to appoint a proxy does not apply to persons whose shares are held on their behalf by another person and who have been nominated to receive communication from the Company in accordance with article 132 of the articles of association of the Company ("nominated persons"). Nominated persons may have a right under an agreement with the registered shareholder who holds shares on their behalf to be appointed (or to have someone else appointed) as a proxy. Alternatively, if nominated persons do not have such a right, or do not wish to exercise it, they may have a right under such an agreement to give instructions to the person holding the shares as to the exercise of voting rights.
- 10. Shares held in uncertificated form (i.e. in CREST) may be voted through the CREST Proxy Voting Service in accordance with the procedures set out in the CREST manual. Shareholders wishing to vote online should visit www.signalshares.com and follow the instructions.
- 11. To be valid, this Form of Proxy must be completed, signed and returned so as to reach the Company's registrars, PSX 1, Link Group, at Central Square, 29 Wellington Street, Leeds, LS1 4DL by no later than 10:30am (UK time) on Tuesday, 25 January 2022 (or, if the General Meeting is adjourned, 48 hours (excluding any part of a day that is not a working day (within the meaning of Article 96(4b) of the Companies (Jersey) Law 1991)) before the time fixed for the adjourned meeting).
